ELIGIBILITY

➔ – Open to any artist residing in New England.
– All work must be painted with aqua media on paper, unvarnished and framed under plexiglass. No color Xerox copies, color lasers, monotypes, pastels or computer generated work. Collage must be completely of aqua media. Work may not have been done in a class or under a teacher's supervision.

ALL WORK MUST BE FOR SALE.

NOTE: The Screening Committee has the right to refuse any painting that does not meet the stated specifications or is not accurately represented. No work exhibited in past New England Watercolor Society shows is eligible.

ENTRY/CD SUBMISSIONS

- ➔ – Up to 3 images may be submitted; only one may be selected.
– Jpeg files should be no larger than 1200 pixels in either direction, 300 dpi.
– CDs & digital files should be clearly labeled/named starting with the artist's name, numbered corresponding to the entry form.

- Please limit naming convention to no more than 30 characters. Submit files that can be read on both MAC and PC.

Accepted CD will not be returned and will be kept in the permanent collection of New England Watercolor Society.

Notification of acceptance will be mailed by August 3, 2009.

FRAMING

➔ **WHITE AND OFF-WHITE MATS ONLY.** All work must be framed under plexiglass. Wires must be attached so that they are not visible when the work is hanging. Work not conforming to regulations may not be hung.

DELIVERY OF ACCEPTED WORK

➔ No shipped work will be accepted.

All work must be hand delivered to the Art Complex Museum on August 29 or 30, from 1-4:00 pm

PRIZES

➔ \$2,000 in awards.

SALES

➔ A forty percent commission will be taken on all sales. Paintings will be sold at the price originally stated by the artist on the entry form. No P.O.R.'s.

New England Watercolor Society reserves the right to photograph paintings or use slides for publicity purposes.
