Eligibility

- Open to any artist residing in North America and Hawaii.
- All work must be entirely original, painted with aqua media on paper, unvarnished and framed under Plexiglas.
- No color Xerox copies, color lasers, monotypes, pastels or computer generated work.
- Collage must be completely of aqua media.
- Work may not have been done in a class or under a teacher's supervision.
- Art may not be withdrawn early, and no changes in pricing or catalogue information may be made after acceptance

- ALL WORK MUST BE FOR SALE.

NOTE: The Screening Committee has the right to refuse any painting that does not meet the stated specifications or is not accurately represented. No work exhibited in past New England Watercolor Society shows is eligible.

Upload Image Submissions

- Log onto www.newenglandwatercolorssociety.org
- Look for the Upload Link
- Upload up to 3 images; only one may be selected.
- Jpeg files should be no larger than 1200 pixels in either direction and 300 dpi.
- Digital files should be clearly labeled/named starting with the artist's name and numbered corresponding to the entry form.

Framing

- **WHITE AND OFF-WHITE MATS ONLY.** All work must be framed under Plexiglas. Wires must be attached so that they are not visible when the work is hanging. Work not conforming to regulations may not be hung.

Delivery of Accepted Work

- Shipped work must arrive at North Shore Arts Association by September 18. Please include Handling Fee of \$50.00. Shipping instructions will be sent on acceptance into the show.
- Hand delivered work must arrive at North Shore Arts Association on Sept. 19 from 12 noon to 5 pm and Sept. 20 from 10 am to 5 pm.

Sales

- All work must be for sale.
- Forty percent commission will be taken on all sales. Paintings will be sold at the price originally stated by the artist on the entry form. No P.O.R.'s.

Return of Work

- Hand delivered work must be picked up at the North Shore Arts Association on Sunday October 24, from 12 to 5:00 pm or on Monday October 25, from 10 am to 5 pm.
- Any painting not picked up on these dates will be stored by NSAA at the owner's expense and may not be accessible until the art association re-opens in May 2011. Shipped paintings will be returned to artist after October 26.
