## ARTIST PROFILE

# Mike Mazer



AT AGE FOUR, MY FAMILY MOVED FROM BOSTON WHERE I WAS BORN, to a rural area consisting of dirt roads and expansive woods. Neighbors were few and far between. None had any children close to my age. This was in the early 1940’s during WWII and the post depression, an era of scarce supplies and when pennies counted. My preschool years and beyond had me responsible for raising and caring for our 300-500 chickens. Part of that would include the long walks to deliver and sell the eggs going door to door. This experience would have a pronounced influence on my life.

Along with the eggs, I carried a pad of paper and a well-used pencil in my pocket. I would periodically stop to sketch the ponds, ducks, woods, barns, houses or neighbors in their varying activities. At night, I would draw the wartime leaders’ portraits or events that could be found in the front page of the newspaper. During these preschool years, I was unhappy that some of my drawings didn’t look quite right, yet I didn’t know how to fix them. By saving some of them, I thought, as I got older, I could learn how to correct my earlier mistakes. Thus, at that time I put them away in a portfolio, which I subsequently carried with me wherever I went, to be used as a future reference.

My neighbors were aware of my drawing habits. Before long while delivering the eggs, I found myself being invited in for a snack and a good talk. A few neighbors had purchased paint and other art supplies for my use, which they kept at their house. They encouraged me to stay awhile and paint. I thought it was a terrific idea while also being able to get away from my chores for a while. All I had to do was to paint a picture of whatever they requested. From the age of five to nine years this continued almost on a daily basis including my afternoons after school. My neighbors’ understanding, companionship, and nurturing of my soul and artistic tendencies was most instrumental in my maturation.

However, the terrible inhumanity of war and the suffering of people from illnesses deeply disturbed me. There was an overwhelming need within me to find a way to help others. Not long thereafter, my family went to visit my uncle who had just returned from five years overseas as a wartime physician. As we all sat down to dinner, the phone rang. It was the hospital calling for my uncle to immediately attend a critically ill patient. Even though I would have to wait for him in the car, I begged to go with him. When my uncle returned to the car I asked, “did you help the patient?” He answered, yes. I then asked “will he live?” Again, he answered yes. At that point I knew I wanted to become a physician to be there for others.

When I came home from the Vietnam conflict as a physician, I was given a wrapped package, by my father. Inside were more of my earlier lost drawings that he wanted me to have, to place into what I thought was my ‘secret’ portfolio.

**Wendy Hale** was juried into the Duxbury Art Association Winter Juried Show, Jan. – April, and the Copley Society “Stirrings” show in February. She exhibited at the South Shore Arts Center Train Show and their Rhythms show. She has two solo exhibits opening this spring, the Front Street Gallery in Scituate in May and the Paul Pratt Library in Cohasset, May – June.

**Mike Mazer** was accepted into the Top 100 for the Paint America Art Competition (formerly Arts for the Parks). He had two paintings chosen for inclusion in the U.S. Coast Guard’s Art Exhibition; they will become part of the USCG’s permanent collection in Washington, D.C. Five of his marine paintings were chosen for the Upstream People Gallery’s 10th On-line International Realism Exhibition where three of the works received Special Recognition Awards. Mike will also be exhibiting this month in the Western Colorado Watercolor Society’s 16th National; Midland Arts Association’s 2008 Spring National in Texas; the Heartland Artist’s National Exhibition in Merriam Kansas; The International Guild of Realism’s Winter show in Scottsdale, Arizona and the Watercolor Society of Alabama’s 6th National.

time. The fact that we are “on our own” now in this building presents challenges for us. For example, all gallery sitters need to learn their way around the locks and lights in this building.

**Scheduling** — The church staff has the job of overseeing many different groups of people using the Music Room (our main gallery) and scheduling did not go smoothly. The NEWS schedule was approved and then changed twice. Of course the staff’s primary responsibility is to their religious community. The church hosts religious services, daily AA Meetings, programs for the elderly and homeless, many different music groups, performing arts programs, children’s programs, community groups — and artists such as NEWS. On several occasions there were other groups using the Music Room at the same time that it was scheduled for us. Sometimes this was awkward; other times it was fun. Some of you have expressed indignation at this so let me explain. We do not pay rent to be there. There is however room for better agreements about how we want to be scheduled.

**Security** — The Music Room as it is in frequent use when we are not there. All of the other groups have the same arrangement with the church that we do, 1. they promise to lock the Music Room doors when they leave and 2. they promise to keep someone stationed in the downstairs lobby when the front door to the sidewalk is being kept open. For increased safety of the artwork we use special wire attachments on paintings in the lower lobby, which makes the removal of paintings more difficult. However, I’m sure you can see that the security level throughout a building in such constant use cannot be extremely tight. It’s similar to displaying artwork in a hospital, a library, rest home or community building... it’s not as secure as a museum or gallery or art association where the art is actually being watched.

**Sales** — The galleries and art associations with whom we’ve worked previously have provided more than merely someone to handle the building. They provided someone interested in selling art. I would like to encourage all of you, while you’re gallery-sitting, to take a good look at the famous Green Book, which our Treasurer **Joan Griswold** created. In it you’ll find articles with tips on the subtle art of encouraging an art purchase. Is this a skill you could use in your own studio? Would it be fun if you actually sold a piece for someone else? Yes! And Yes!
